Scope of Work:

Executive Summary:

The scope of this project involves providing administrative services to the Florida Department of Community Affairs for processing applications for product and entity approvals submitted on the Building Code Information System (BCIS). The reviews and resulting reports will provide recommendations that will serve as the basis for approval of products and entities by the Florida Building Commission. Specific tasks required to successfully administer and manager the Florida Product Approval system include:

- Provide administrative reviews of applications for products to determine compliance with the checklist from Rule 9B-72 130(5) FAC.
- Provide administrative reviews of applications for entity approvals.
- Provide the Product Approval Oversight Committee (POC) and the Florida Building Commission (FBC) recommendations for approval of products and entities for the Product Approval System based on the administrative reviews.
- Update the BCIS system on the status of applications for products and entities.
- Provide recommendations for changes or enhancements to the BCIS system on the Product Approval Module. An overview of the proposed process for administering the program is provided below.

Douglas Harvey, Executive Director of BOAF will serve as the Project Administrator. The Program Administrator will have the following primary responsibilities:

- Oversight and management of the program including application reviews
- Receipt of incoming mail and distribution
- Update BCIS system on status of applications
- Receipt of incoming telephone calls
- Attend FBC meetings
- Distribute applications for review by subcontractors
- Compilation of reports for reviews
- Notify applicant of results of the review

Existing and new BOAF staff will be utilized to assist in performing the proposed tasks. Subcontractor's may be used where needed to perform reviews and may also perform other tasks as assigned by the Program Administrator.

The process for product approval under the Florida Building Code, the Florida Building Commission and the BCIS is based on an applicant submitting a completed and validated product application with required documentation or an entity application through the BCIS system for review. The proposed cutoff date for each cycle of review is established by the Commission with a time certain previous to the Florida Building Commission scheduled meeting. This cutoff date allows reports and evaluations to be performed in preparation for the meeting to be presented to the Commission for action.

The flow of information, timeframes and milestones are assumed at this time to be as follows:

- a. Product and Entity Reports due to Florida DCA staff - 2 weeks prior to Florida Building Commission Meeting
- b. Compilation of complete report and posting application to the BCIS website - 1 week
- c. Product and Entity application reviews and notification to applicants regarding review comments - 3 weeks

A report will be generated of all validated product applications and entity applications that are ready to be reviewed and were submitted before or on the cutoff date for submittal. Contractors will begin the reviews. Subcontractors may be needed and used for reviews and verification of the information. Subcontractors will complete a detailed review form (checklist) that will identify the proposed status of the application. The administrative review will be performed using a checklist approved by the Department based on checklist from Rule 9B-72 130(5) FAC. The results of a completed review for an application will serve as the basis for the recommendations to the Florida Building Commission on product approval. Applications that are determined to be in compliance with the checklist shall be recommended for approval to the Product Oversight Committee and Florida Building Commission. Applications recommended for approval will be placed in a Pending FBC Approval status on the BCIS website, or as otherwise directed by the Commission and DCA staff, as agreed to.

Applications that are determined to be "not in compliance" or "incomplete" will be notified of the specifics pertaining to the status of the application. Incomplete applications and applications that are not in compliance with the checklist will not be forwarded to the Commission for approval and every effort will be made to contact the submitting party for corrections in a timely manner as specified in the requirements. The applicant must respond through the BCIS system to amend or update the application in order to provide the applicable documentation. If an application expires or the required information is not provided, the application will be placed in front of the Commission at the next scheduled Florida Building Commission meeting and recommended for denial. If the applicant responds to the comments through the BCIS system and the application is re-validated, the application will be reviewed during the next review cycle (i.e. the cutoff dates apply to re-submitted applications). The application will be processed in the same manner as the initial review; however if it is deemed to be incomplete or not in compliance on the second review, it will be recommended to the Product Oversight Committee and Florida Building Commission for denial. All product and entity approval application reports meeting the application cut-off date will be posted on the BCIS website prior to the Florida Building Commission meeting. The BCIS report will be delivered to Florida DCA staff prior to the Florida Building Commission meeting. A summary report will also be provided that will outline the results of the review and the status of each application. The actions of the Florida Building Commission related to the specific applications will be posted on the BCIS website.

1.10 Response To Additional Requirements:

- 1) Contractor must cease performing any other Rule 9B-72, F.A.C., functions if selected to perform this administrative service. Fees will be paid directly to the Contractor by the manufacturer, either via the Building Code Information System at www.floridabuilding.org or other means, as determined by the Department and Contractor.
Response: This is not a problem as BOAF does not perform other work related to Rule 9B-72, F.A.C.
- 2) If the BCIS is used to process payments, Contractor shall comply with all relevant security standards and specific payment credit card industry requirements that maintain data security and compliance throughout the contract.
Response: BOAF has used the BCIS to process payments for Formal (Binding) interpretations and can continue to use this system.
- 3) Contractor shall provide a Statement of independence attesting that no conflict of interest exists between the Contractor and the Florida Building Commission (FBC) approved certification agencies, test laboratories, quality assurance entities, evaluation entities or Florida architects or engineers conducting product evaluations.
Response: Statement is attached in the package.
- 4) The Contractor shall agree to any changes to the scope of work subsequently approved by the Commission.
Response: Provided any changes made do not have a financial impact or respondent is provided the opportunity to accept or withdraw at such time the changes are made.
- 5) The Contractor shall establish an office in Florida to provide this service.
Response: BOAF currently maintains and intends to continue to maintain an office at 3697 Lake Emma Road, Lake Mary, FL 32746
- 6) The Contractor shall investigate product complaints and serve as expert witness for the Commission, as directed by the Commission.
Response: This is acceptable to BOAF.
- 7) The Contractor shall coordinate with the Department to provide recommended BCIS enhancements on the Product Approval Module.
Response: We are preparing a list for discussion during and after negotiations.
- 8) The Contractor shall conduct all communications with the product approval and entity applicants through a specified dialogue in-box designated on the BCIS. (The BCIS will be enhanced with this function)
Response: We look forward to the enhancement.
- 9) Contractor shall provide annual certified financial statements sufficient to determine the efficacy of the program until a threshold of \$300,000 in revenue is reached; thereafter, annual financial audits by a certified auditing firm, to be selected by the Contractor and approved by the Commission within 60 days after the contract is awarded, shall be

provided. Financial audits for previous fiscal year contracts shall be provided annually to the Department by November 1.

Response: This is an acceptable portion of the package.

10) Contractor shall, at a minimum, develop and conduct on-site validator training, to be approved by the POC, at contractor's expense every six months. The contractor shall communicate electronically (emails or telephone conference) to all validators and the Department the common validation mistakes discovered during each application cycle within ten (10) calendar days following each scheduled Commission meeting. The contractor shall report on validators with history of poor performance and Quality Control suspensions at each scheduled POC meeting.

Response: This is an acceptable portion of the package anticipated to improve the program. Training would be held at the BOAF office unless directed differently by the Commission to be done in conjunction with a Commission meeting at the Commission meeting location. Reports would be submitted to the Commission as directed.




ATTACHMENT 2 - CERTIFICATION OF DRUG-FREE WORKPLACE PROGRAM

201.087 preference to businesses with drug-free workplace programs--Whenever two or more bids, proposals, or replies are equal with respect to price, quality, and service are received by the state or by any political subdivision for the procurement of commodities or contractual services, a bid, proposal or reply received from a business that certifies that it has implemented a drug-free workplace program shall be given preference in the award process. In order to have a drug-free workplace program, a business shall:

- (1) Publish a statement notifying employees that the unlawful manufacture, distribution, dispensing, possession, or use of a controlled substance is prohibited in the workplace and specifying the actions that will be taken against employees for violations of such prohibitions.
- (2) Inform employees about the dangers of drug abuse in the workplace, the business's policy of maintaining a drug-free workplace, any available drug counseling, rehabilitation, and employee assistance programs, and the penalties that may be imposed upon employees for drug abuse violations.
- (3) Give each employee engaged in providing the commodities or contractual services that are under bid a copy of the statement specified in subsection (1).
- (4) In the statement specified in subsection (1), notify the employees that, as a condition of working on the commodities or contractual services that are under bid, the employee will abide by the terms of the statement and will notify the employer of any conviction of, or plea of guilty or nolo contendere, to, any violation of chapter 893 or of any controlled substance law of the United States or any state, for a violation occurring in the workplace no later than 5 days after such conviction.
- (5) Impose a sanction on, or require the satisfactory participation in a drug abuse assistance or rehabilitation program if such is available in the employee's community by, any employee who is so convicted.
- (6) Make a good faith effort to continue to maintain a drug free workplace through implementation of this section.
