I would like to know whether or not fire protection sprinklers are required on 3+ story single family residential buildings.

The 2004 Code Book lists different types of multiple family residential buildings 3 or more stories in R324.1 but has no reference to single family buildings 3 or more stories in height. Previously, when referring to table 500 which is no longer in the 2004 Code Book, we had to type the house protected or unprotected. Is this still necessary since there is no table 500 nor can I find a reference to single family 3 or more story buildings.

We have several projects where this is an issue and I would like to know if my interpretation is correct in that we don't need fire protection sprinklers in single family residential buildings 3 or more stories in height.
