Good afternoon Oriol,

Attached is an Excel workbook with data from our incident databases for swimming pool lighting electric shocks from 2006 to the present. Unfortunately, the details are very sparse so I don't know how much this will help you. There are two spreadsheets in the workbook: CPSRMS and NEISS. The sheet labeled CPSRMS represents reports from the following CPSC databases: Injury or Potential Injury Incident (IPII), Death Certificate (DTHS) and In-Depth Investigations. In some cases there are multiple incident report numbers for a single incident, but we've summarized the information into one line. For two of the incidents (Springfield, GA and North Miami), follow-up investigations were conducted by CPSC Field staff, consisting primarily of a compilation of the police reports and other available documentation. For the 2010 Springfield, GA incident, a "Pool flood light" was implicated, but no other information is provided about the luminaire. For the 2014 North Miami, FL incident, a pool light was implicated

without any specific information being available on the luminaire. In both cases, improper grounding was cited. The reports for these are 120227HCC2373 and 140528CNE0001; if you are interested in these reports, we'll need to FOIA them for you.

The second sheet is incident information from the National Electronic Injury Surveillance System (NEISS), which is a national probability sample of hospitals in the U.S. and its territories. For this system, the emphasis is on the treatment and disposition of the patient, and minimal information is available on the incident/product involved.
