MEETING FACILITATION:

Welcome:

Time: 10:00 a.m.

Mr. Blair welcomed everyone to the concurrent meeting of the Electrical TAC, Roofing TAC and Swimming Pool TAC.

Roll Call:

Mr. Blair performed roll call for the Electrical TAC. A quorum was determined with 9 members present at roll call.

Agenda Approval:

Commissioner Fischer entered a motion to approve the agenda for today's meeting as posted. Mr. Territo seconded the motion. The motion passed unanimously with a vote of 9 to 0.

Approval of Minutes from March 31, 2021:

Mr., Burdick requested that his first name be corrected on page 2 of the minutes.

Mr. Burdick entered a motion to approve the minutes from March 31, 2021 as amended. Mr. Hall seconded the motion. The motion passed unanimously with a vote of 9 to 0.

To review and accept final draft report for research project titled "Evaluation of the Cost Impact and Benefit of the 2021 I-Code Changes (Prescriptive Code Changes).":

Mr. Madani provided the background on this research project for the Committees.

Dr. Raymond Issa, UF provided a detailed Power Point presentation summary of the final draft report titled "Evaluation of the Cost Impact and Benefit of the 2021 I-Code Changes (Prescriptive Code Changes)."

TAC Comments/Clarification:

Mr. Guerasio stated that in the TAC meetings yesterday it was advised that the F1 and G1 charts appeared to be mislabeled, and noted that Dr. Issa will be correcting.

Mr. Territo questioned the large increase in the 2017 costs compared to the 2021 costs, as reflected in the chart.

Dr. Issa explained the chart is comparing 2021- 2018 and the cost data based on the 2017 code to generate the three columns to obtain averages.

TAC Comments/Clarification (cont.):

Bryan Holland stated there were a few edits. He noted four changes would be 445-18(d) page 217, 480.7 page 218, 694.22(c)(1) on page 255 and 706-7 should be 706.15(a) on page 261 of the report.

Mr. Blair requested that Mr. Holland send all of these requested updates/changes to Mr. Madani in writing to ensure the information was updated as requested.

Mr. Holland stated he would send all of the update request to Mr. Madani.

Mr. Holland noted that he would also like to speak about page 232 referencing section 551, stating that RVs are not included in the code that all cost on this is paid by the RV purchasers. Next, he stated that on page 234, the section listed as 555.9 is not new, but was relocated from section 2108(c). Mr. Holland also noted that the section listed as 620.62 on page 237 should be 620.65.
