They must answer the questions correctly to complete the course. There were approximately 20 sections of course content and only 2 questions (with no identified correct answers) posted for use. Either the "course set up" and the "course evaluation" need to be rewritten, or more questions (with identified answers) need to be added. Commissioner Dean also stated that the 2017 reference in the syllabus "Learning Objectives" needs to be changed to 2020.

Mo Madani agreed with Mr. Schneider. It is not incorrect to reference the 2012 Accessibility Code as the most current version.

8.) Education Administrator Activity Report

- -- Submitted within FIVE (5) WORKING DAYS AFTER EACH COURSE
- -- Advertisement (must be approved in advance)
- -- Sign in sheets as acceptable for each licensing board
- -- Separate sign in sheets for licensees and non-licensed employees
- -- Non-licensed employee sign in sheets must include type of proof submitted
- -- *Copy of course evaluation for each attendee

*Failure to demonstrate that 75% or more of trainees were satisfied or highly satisfied with the course instructor will result in a 1% penalty for each 5% increment or portion thereof that the percentage of satisfied trainees fall below 75%.

9.) ED POC member advanced course evaluation information

Discussion: Michael Clark stated that he developed this document because of ED POC members (over the years) asking him for direction when evaluating courses as ED POC members. Mr. Clark thought that the information contained could be of assistance. Commissioner Dean stated that she was not quite sure what was meant in the section of the document that said that ED POC members main job is to verify the correctness of all building code related content in the course materials. She stated that she thought that was the accreditor's job. Mr. Clark said that she was correct, but that the ED POC members job was to verify what the accreditor had previously approved. Commissioner John then stated that he felt that the Education Rule Language should be strictly followed regarding course content, including what was contained in course titles. Justin Vogel, FBC attorney, stated that unless the rule language is statutorily mandated or required, then some leeway may exist as to its interpretation. Also, a meeting participant stated that (for example) the term "Internet" currently used in the rule language, is much more restrictive in today's world versus the more inclusive "distance learning". Thomas Campbell stated that because of all the discussion, it was probably a good idea to look at the Education Rule Language to determine if some tweaks or changes to the language were needed. He further said that if that were the case, then it would be presented to the ED POC at the February (2021) meeting. Everyone agreed to that course of action. No further motion was needed.

10.) Accreditor & Training Provider process information regarding the development, accreditation, and approval of advanced courses

Discussion: Michael Clark explained that this document was developed as the basis for a training session with both training providers and accreditors, to ensure that everyone was on the same page when developing and accrediting courses. As with the ED POC course evaluation document, no further action will be taken regarding this document until the Education Rule Language is possibly modified.

Identify future POC member discussion items No future ED POC member discussion items were forthcoming. General public comment

Larry Schneider, a training provider, asked Thomas Campbell if he was aware of the Board of Architecture (BOA) possibly changing their process regarding how advanced courses were approved. Previously, advanced courses were accredited and approved by the Florida Building Commission, then approved by the BOA. The possible change would be that in the future, the BOA would be the only approving authority. Thomas Campbell stated that he was aware of this possible change.
