TUESDAY, FEBRUARY 25, 2003

COMMISSION PLENARY SESSION

Agenda Review and Approval

The Commission voted unanimously, 16 - 0 in favor, to approve the agenda as approved.

Review and Approval of January 14, 2003 Meeting Minutes

The Commission voted unanimously, 16 - 0 in favor, to approve the minutes as amended for the January 14, 2003 Commission meeting.

Corrections to Minutes:

Commissioner Greiner reported that it was his intent that the Commission's action on DCA02-DEC-352 was to table the statement and send it to the appropriate TAC for review and Commission action at the February 2003 meeting.

Review and Approval of Commission's Updated Workplan and Meeting Schedule

The Commission voted unanimously, 17 - 0 in favor, to approve the updated workplan as presented.

(Attachment 2 – Workplan)

Chair's Discussion Issues and Recommendations

Chairman Rodriguez recognized Commissioner Patterson, who offered on behalf of the entire Commission, appreciation for Charlie Hickey's service to the Commission.

Chairman Rodriguez reported that DCA Secretary Colleen Castille attended Sunday's TAC chair meeting and updated members on how the Governor's proposed budget would likely affect the future administration of the Commission. The Chair indicated that Secretary Castille offered several possible models that are currently under consideration by the Department. In summary, they include requests for proposals, requests for information, management corporations such as the Engineering Board or the Housing Finance Corporation, or possibly some sort of sole-sourcing model that might allow the Department to contract directly with current staff.

Chairman Rodriguez reported that AHCA has requested that the Commission support their efforts to seek legislative action to clarify the law regarding facility licensing specific standards that are incorporated into the code. Skip Gregory from AHCA provided the details of the request. Mr. Gregory requested that the Commission work with AHCA's efforts to clarify in law that the facility licensing regulation should be interpreted, enforced, and waived by the Agency and not the local building official.

Chairman Rodriguez reported that DCA has requested that the Commission move the April 8, 2003 Commission meeting from Pensacola to a more central and economical location due to budget constraints.

Finally, Chairman Rodriguez made the following TAC/POC appointments for 2003: There will no longer be an Education POC since there is no longer an education program for the Commission to administer.

Suzanne Marsall will move from the Energy TAC to the Education TAC,

Karl Thorne will move from the Code Admin. TAC to the Energy TAC,

Karl Thorne will also be on the Product Approval POC

Herminio Gonzalez will move from the Education TAC to Code Administration,

Peggy Patterson will move from the Education POC to the Energy TAC,

Michael Kravit will move from the Electrical TAC to the Fire TAC,

Christ Sanidas will move from the Fire TAC to the Product Approval POC,

Tony Apfelbeck is appointed to the Fire TAC,

Steve Corn will move from the Accessibility TAC to the Education TAC and replacing Ed Kinburg,

Jay Dagner is appointed to the Electrical TAC under general interest, and Roy Van Wyck is moved to the consumer category,

Dan Shaw is appointed to the Product Approval POC, and,

Ted Berman is appointed to the Structural TAC replacing Raul V. Rodriguez.

Finally, all other TAC positions will remain the same and are re-appointed.

Commission Actions:

Motion – The Commission voted unanimously, 20 - 0 in favor, to authorize the Chair on behalf of the Commission, to draft a letter outlining the Commission's concerns and recommendations regarding the recommended outsourcing of the Commission's administration. This letter should be presented at the next Commission meeting for Commission review and consideration.

Motion – The Commission voted 14 – 5 in support, to support AHCA's efforts to seek legislative clarification that it is the intent of the law that Chapter 4 facility licensing regulations should be enforced, interpreted, and waived by the appropriate state agency, and that all life safety regulations should be moved to the core of the Florida Building Code so that they would remain under the authority of the local building official.

The motion failed due to the Commission's 75% approval threshold requirements. **Motion –** The Commission voted unanimously, 18 - 0 in favor, to reconsider their actions on AHCA's request.

Motion – The Commission voted unanimously, 18 - 0 in favor, to direct staff to work with AHCA and other state agencies in a manner that will facilitate state agency's ability to enforce, interpret, and waive their respective Chapter 4 facility licensing regulations and report the results back at the Commissions April 2003 meeting. **Motion –** The Commission voted unanimously, 19 - 0 in favor, to move the April 2003 Commission meeting from Pensacola to a central Florida location.

Consideration of Accessibility Waiver Applications The Commission reviewed and decided on the Waiver applications submitted for their consideration.

Rule Development Workshop for Rule Chapter 9B-1, Manufactured Buildings

Following opening of the hearing, Chairman Rodriguez asked for public comment on the proposed rule. Following public comment, Commissioner Carson presented the POC's recommended amendments to the draft rule.

Commission Actions:

Motion – The Commission voted unanimously, 19 - 0 in favor, to approve the proposed amendments as presented by the POC and to proceed with rule adoption for Rule 9B-1. *Commission amendments:*

Motion – The Commission voted unanimously, 19 - 0 in favor, to amend Rule 9B-74 to authorize the waiver of the 90 day time limit established by Chapter 120, Florida Statutes, as it applies to the buildings; and, to add the following language to 9B-1.006 (4), ... with <u>Chapter 120 and</u> the....

Rule Development Workshop for Rule Chapter 9B-3.054, Non-binding Advisory Opinions

Following opening of the hearing, Chairman Rodriguez asked for public comment on the proposed rule. Following public comment, Commissioner Thorne presented the Code Administration TAC's recommended amendments to the draft rule. *Commission Actions:*

Motion – The Commission voted unanimously, 19 - 0 in favor, to approve the proposed amendments as presented by the TAC and to proceed with rule adoption for Rule 9B-3.054.

Commission amendments:

Motion – The Commission voted unanimously, 19 - 0 in favor, to amend Rule 9B-3.054 by revising section 2(c) to reflect the following change: "<u>The response shall be sent to</u> the requestor within 21 days and in no event may exceed 30 days. If more than 21 days notify petitioner."

Legal Staff Recommendations for Commission Action

Consideration of Actions Regarding FPSA Challenge of Pool Alarm Standards

Jim Richmond reported that the judge had ruled on the FPSA Challenge of Pool Alarm Standards in the FBC. The ruling largely supported the Commission's actions, however, the judge ruled on issues not presented/contested in the challenge hearing that could affect some of the Commission's decisions. Richmand recommended that the Commission consider challenging the judge's final order.

Commission Actions:

Motion – The Commission voted unanimously, 20 - 0 in favor, to authorize staff to challenge the judge's final order.

Motion – The Commission voted 16 – 14 in favor, to support the current language in the code as it applies to pool alarm systems and not to negotiate code changes on battery powered alarms.

Further, future amendments to the Florida Building Code should provide a rationale as to their intent that may serve to provide an explanation on the thinking behind the code amendment.
