It has come to our attention that there is an error in the petition that needs to be revised.

Under the <u>Situation</u> section, we wrote:

...The repair method selected involved removal and replacement of non-damaged components upslope of the damaged components, which added an additional 25 percent of the roof section area to be disturbed as part of the repair...

That sentence should be revised as follows:

...The repair method selected involved removal and replacement reinstallation of non-damaged components upslope of the damaged components, which added an additional 25 percent of the roof section area to be disturbed as part of the repair...

This revised verbiage is similar to what we wrote in the <u>Summary</u> section:

...If the removal and reinstallation of non-damaged components are counted toward the 25 percent threshold stated in Section 706.1.1, a relatively small roof repair could trigger a complete roof section replacement, depending on the area of non-damaged roofing components removed and reinstalled as part of the repair...
