### **AmeriGlide Distributing 2019 Terms and Conditions**

#### **Acceptance**

The contract shall consist only of our offer and your acceptance of the Order Form and these terms, nothing else shall form part of the contract and be binding on either you or us. It is our responsibility to supply you with goods that meet your consumer rights. Nothing in this contract affects your statutory rights. By accepting you acknowledge and agree to have read, understood and agreed to be legally bound to the terms and conditions set out below. Unless otherwise stated, you agree to pay as follows: 100% payment upon signed acceptance.

#### **Payment**

- Payment to be made by check or ACH bank transfer only unless otherwise noted.
- If credit card payment is requested and accepted a 3% service charge will be added to the invoice.
- Overdue Invoice: A service charge of 18% annually shall apply to overdue accounts past thirty (30) days.
- If you do not pay within sixty (60) days from the billing date we may choose to do one of the following:
   1) suspend all work until the amount has been paid, or 2) declare all sums for the unexpired term of this agreement due immediately and terminate this agreement. This will void warranty and technical support.

#### **Cancellation Charges**

The following are charges that will be applicable during the production process of items purchased.

25% of purchase value

50% of purchase value

80% of purchase value

100% of purchase value

Completion of engineering drawings

Once equipment enters production

Once production is 50% complete

Once production is 100% complete

**Note:** that once production of purchased equipment has been completed, the product is non refundable. Products are custom built and cannot be returned once completed.

#### **Specific Terms and Conditions**

#### 1. Responsibility of Purchaser

- a. Purchaser is responsible for checking the product for damages upon its arrival. Once delivery has been accepted, the purchaser accepts responsibility for the condition of the product.
- b. Purchaser is responsible for unloading delivery. Delivery to a job site requires the customer to have a forklift available, or it must be picked up at a local terminal. In some cases, not all customers can purchase forklift delivery.
- c. In the event that the customer requests a change in the delivery address after the product has been shipped from the manufacturer, a minimum fee of \$695 will be assessed to cover the associated administrative and logistical expenses incurred by the seller.
- d. Purchaser is responsible for all local and state guidelines. This includes and is not limited to permitting, inspection, installation and operation of AmeriGlide products.
- e. The purchasor shall be responsible for obtaining all the relevant pre-construction and post-construction permits to be availed by the purchasor as mandated by applicable laws and policy guidelines for work of this nature. The Purchasor shall maintain and, to the extent applicable renew such permits.

  AmeriGlide is responsible for providing the product.

#### 2. Terms and Conditions of Sale

- a. In consideration of AmeriGlide Distributing 2019 performing the services herein specified, you expressly agree to indemnify, defend, save harmless, discharge, release and forever acquit AmeriGlide Distributing 2019, our officers, our employees from and against any and all claims, demands, suits, and proceedings brought against us or our employees of any nature whatsoever, including but not limited to loss, damage, injury or death that are alleged to have arisen from or alleged to be in connection with misuse, maintenance, operation or condition of the equipment covered by this agreement.
- b. Typical lead time for delivery can vary based on product.
- c. Production lead time begins upon receipt of signed approval drawings and execution of contract terms.
- d. A **maximum of 2** engineered drawing revisions are included in this contract price. Subsequent revisions are chargeable at \$245 per change request.
- e. Change orders must be communicated with a signed change order request document approved by both parties and may be subject to additional cost(s).
- f. **Storage fees:** Equipment may be stored for up to 10 business days after the requested equipment delivery date at no charge. Additional storage is available at \$50/day.
- g. Quotes are valid for 7 business days from the date of issue, quotes older than 7 business days may be subject to repricing.
- h. Installation must be completed within 1 year of contract acceptance or price increase may result.
- i. **Attorney Fees**. In the event that there is any controversy or claim arising out of or relating to this Agreement, or to the interpretation, breach or enforcement thereof, and any action or proceeding is commenced to enforce the provisions of this Agreement, the prevailing party shall be entitled to a reasonable attorney's fee, costs and expenses.
- j. Any overdue invoice past 60 days will void the warranty. Interest will be applied.
- k. We reserve the right to deny turn-over of equipment until the complete payment has been received.
- I. Warranty is valid for two (2) years on all parts from the date of shipping.
- m. Installation must be completed by a trained licensed professional. Failure to have a trained licensed professional may result in voiding all warranties.
- n. Any **third party installation** (Installation completed by anyone other than an AmeriGlide Distributing 2019 or their agent and paid separately from this contract) comes with a one hour of free technical service. Each call will be counted as a minimum 15 min call. All technical service calls after the included hour will be billed at \$200 per hour with a minimum call / charge of \$50.00 for 15 mins. This does not include the initial hold time and must be paid in advance on a valid credit card. All technical service call fee's are non refundable.
- o. Any **third party installation** (as indicated above) revokes any right to sue for component breakage, injury related to use, or damage related to other third parties in the form of prejudice or delays in the face of malfunctions of the product or improper installation by that third party.
- p. **Ownership Clause**: Until the product is fully paid, the product shall remain the property of AmeriGlide Distributing 2019 ("AmeriGlide"). In the event that the full payment is not received in accordance with the agreed terms, Ameri-Glide reserves the right to retake possession of the product without further notice. The customer acknowledges and agrees that AmeriGlide has a security interest in the product until full payment is received.
