One (1) Precision Lift Industries lift VPL-500, in accordance with the following features:

- 1) 500lbs capacity, Winding Drum Operation, Speed 24 feet per minute.
- 2) Emergency stop switch, emergency light, and alarm.
- 3) Standard 36" x 48" platform
- 4) 2 landings, travel up to 144."
- 5) Same side Entry/Exit with Solid Lower Panels
- 6) LH Tower with Triangle tower bracket
- 7) 36" Upper Gate Solid Aluminum
- 8) Safety Underpan
- 9) Tower fascia Solid panel.
- 10) Call/send controls at landings.
- 11) Finish: White powder coated
- 12) 12-month parts warranty
- 13) Battery Lowering
- 14) Float Switch
- 15) Full-height solid lower door


