To give you a heads up...see my comments below on the draft report:

**Include a page listing the EBIWG workgroup members and their titles after the title page.**

**Justification:** When reading any report, one of the first questions anyone has is “Who was on this Committee that authored this?” Answering that question, with a well-balanced group of expertise, creates confidence in the report itself. It is also more difficult to dismiss a report when there are key users that are identified as making these recommendations and not just a group identified as a “work group.”

**Delete the “Relevant Provision from Chapter 10, NFPA 1” from page 7 and the annex of the report.**

**Justification:** Two of the three pages in the report annex, pages 1-66 and 1-67, don't relate at all to anything the workgroup discussed. In addition, page 1-65 which is related to what we discussed, is not referenced in the report nor is there any context added to this appendix allow a user to understand the reason for the included appendix page(s). If it is to be retained, it needs context in the core report and a specific reference to the relevant sections. (I still suggest to delete it.)

**Relocate the last three paragraphs in the Conclusion on page 6 into the core text of the report.**

**Justification:** The last three paragraphs in the conclusion are not really a conclusion. They are introductory text and distract from the Conclusion of the EBIWG.

**Change “may” to “will” in the last sentence of paragraph 2 under B. Life Safety on page 4.**

**Justification:** We don't need to temper our response on this with a “may”. The actions we are recommending “will.”

Feel free to let me know if you want to discuss prior to the meeting if you have any concerns.
