### OVERVIEW OF COMMISSION'S KEY ACTIONS AND DECISIONS WEDNESDAY, NOVEMBER 13, 2024

#### I. SPECIAL ISSUE MEETING SUMMARY AND OVERVIEW

The Commission conducted their November 13, 2024 Special Issue Meeting as a web-based and teleconference virtual meeting. At the November 13, 2024 meeting the Commission considered and decided on Chair's issues and recommendations. Specific actions included voting to: 1) Approve the Final Draft Report for the Research Project Titled: "Review and Consider Possible Technical Changes to Section 553.9065, Florida Statutes," as amended, based on the Energy TAC's recommendation, and to recommend that the Legislature incorporate the specified technical amendments into section 553.9065, Florida Statutes; and 2) Approve the Final Draft Report for the Research Project Titled: Reviewing the Standards for Wind-Driven Rain (WDR) Intrusion Through Tracks of Sliding Glass Door Systems During Hurricanes," as amended to incorporate the changes approved by the Hurricane Research Committee and accepted by the principal investigators, based on the HRAC's recommendation.

#### II. CHAIR'S WELCOME

Chairman Bourré welcomed the Commission, DBPR staff, and the public to the November 13, 2024 Special Issue Web-Based and Teleconference Virtual Meeting of the Florida Building Commission.

The expressed many thanks to Jeff Gross for his twenty-one-years (Nov. 13, 2003 – October 24, 2024) of outstanding service to the citizens of Florida as a member of the Commission and chair of the Accessibility TAC. The Chair expressed that the Commission will miss working with Jeff and wished him the best going forward, and again thanked him for his service.

**Rod Hershberger** has been reappointed to serve as the Building Products Manufacturing Industry representative to the Commission. Rod has served since September 14, 2020 and serves as the Product Approval POC chair. Chair expressed that the Commission is very pleased Rod agreed to remain on the Commission, and thanked him.
