The remaining balance is due upon completion of delivery and installation. If Buyer should cancel after initiation of installation, then Buyer will still be responsible for the entire cost as if installation was complete.

All custom applications require a seventy percent (70%) nonrefundable deposit at the time of final measurements; the remaining thirty percent (30%) shall be paid prior to 101 Mobility placing the order with the manufacturer. All custom applications are unique to Buyer and all sales are final. If Buyer should cancel after custom application order is placed by 101 Mobility with the manufacturer, then Buyer will still be responsible for the entire cost of purchase. Customer shall be solely responsible for all permits and permissions, including HOA approval, unless otherwise noted within.

This Agreement shall be governed by, and construed in accordance with, the laws of Florida, exclusive of conflict of law rules. Each party to this Agreement hereby agrees and consents that any legal action or proceeding with respect to this Agreement shall only be brought in the courts of the state where 101 Mobility is located and in the county where 101 Mobility is located. The prevailing party shall be entitled to recover all expenses, including but not limited to, reasonable attorney fees, court costs, legal expenses, and reasonable costs of collection.

The parties agree that if loss or damage should result (i)from the failure of performance or operation; (ii)from defective performance or operation; or (iii)from improper installation or servicing of the System, then 101 Mobility's liability, if any, for the loss or damage thus sustained shall be limited to a sum equal to total monies paid by Buyer to Seller, including but not limited to, price of purchase, installation, and maintenance, and that the provisions of this paragraph shall apply if loss or damage, irrespective of cause or origin, results, directly or indirectly to persons or property from performance or nonperformance of obligations imposed by this Agreement or from negligence, active or otherwise, of 101 Mobility, its agents or employees. There are no warranties of merchant ability which extend beyond the description on the face hereof.
