Comments on the Milestone Inspection Form for Consideration during Rulemaking

Phase 1 Inspection Form Comments

- 1. Page 1: In the opening title add two radio buttons to identify if the inspection submitted is the initial phase 1 report or is an amended phase 1 report as required after completion of any repairs.
- 2. Page 1: Add to the note located in the box identifying the inspection design professional. " Add pages as required to list all additional design professionals assuming responsibility for the Milestone Inspection or portions thereof. <u>Each Design Professional must sign and seal</u> their portion of the work in accordance with Florida Statutes."
- 3. Page 1: Revise the following check boxes where the inspector sums up his findings: <u>Immediate</u> Dangerous Condition Observed; Notify Building and Fire Official; Structural Evaluation May be required, <u>possible Shoring and a Phase 2 inspection is required</u>

Maintenance Needed <u>but does not raise to the level of Substantial Structural</u> <u>Deterioration or Dangerous phase 1 inspection passes</u>

- 4. Page 2: If we provide two seal locations each location should have their own signature spot. Add a signature and date spot at each seal location and remove it from the bottom of the page.
- 5. Page 24: In part 17 Summary of Findings. Partition this section and add a column for "Phase 2 Inspection Require and add a YES and NO check box for each item.

#### Phase 2 Milestone Inspection Form Comments

- 1. Phase 2: inspection section 3 Design professional information. I would suggest this be revised to be the same information as provided on page 1 and 2 of the Phase 1 Inspection Report. It will provide a consistent look and information in the report and for the design professionals signature and sealing of the document.
- 2. Phase 2: Just below section 3 where they repeat the findings in Phase 1 I would title that section as "Summary of Phase 1 findings."
- 3. Phase 2: Section 9 Summary of Findings. Revise the wording as follows:

The Building has Substantial Structural Deterioration <u>or is considered dangerous</u>, Corrective Action is Required.

Because there is already a check box indicating corrective act is required instead of another check box indicating corrective action is required we should just add a note that states <u>"Upon completion of the corrective action the Design Professional in</u> <u>charge of the Milestone inspection must submit an amended phase 1 Milestone</u> Inspection Report per Chapter 18 of the Florida Building Code-Existing Buildings."
