- May be used up to the sizes and daylight openings with glazing and design pressures as indicated in PEL-1073A
- Is Large Missile impact resistant and does not require the use of shutters
- May not be used in the High Velocity Hurricane Zone or Wind Zone 4 areas
- Requires Kuraray Butacite PVB Interlayer, 0.090" thick in 36"x76" unit size and 0.105" thick in 48"x76" size. Requires 0.090" Kuraray SentryGlas Interlayer in unit sizes 68"x76" and 54"x96". Width and height may be transposed.
- Requires ATN PVC frames with current listing as AAMA 303 Certified Profile Licensee
