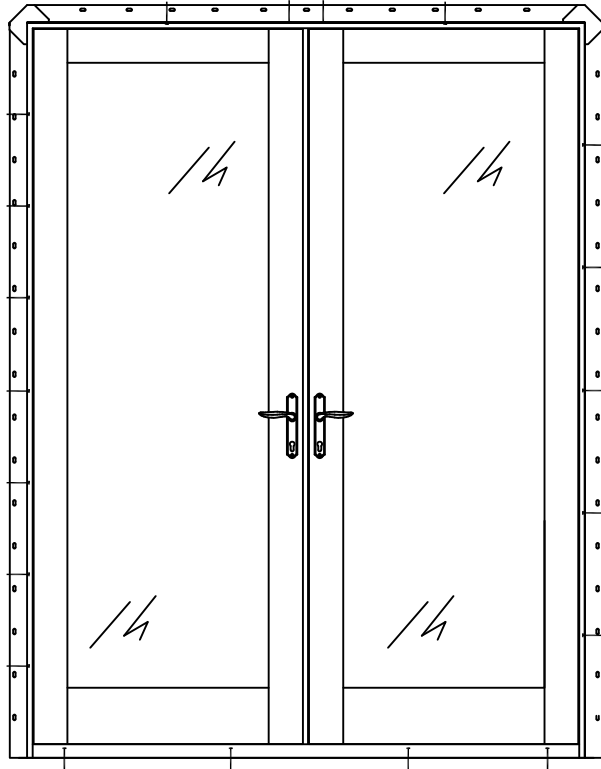

#8 PFH corrosion resistant screws into clip and frame	FULL	See pg. 2

**Installation Method**

Installation Clips	Screws thru the Frame
Sides = 19-3/16" from corners & on center Head = 18" from corners Sill = N/A - See screw instructions	Sides = #10 PFH screws spaced 13-11/16" from corners and on center Head = #10 PFH screws spaced 18" from corners Sill = #10 PFH screws spaced 12" on center

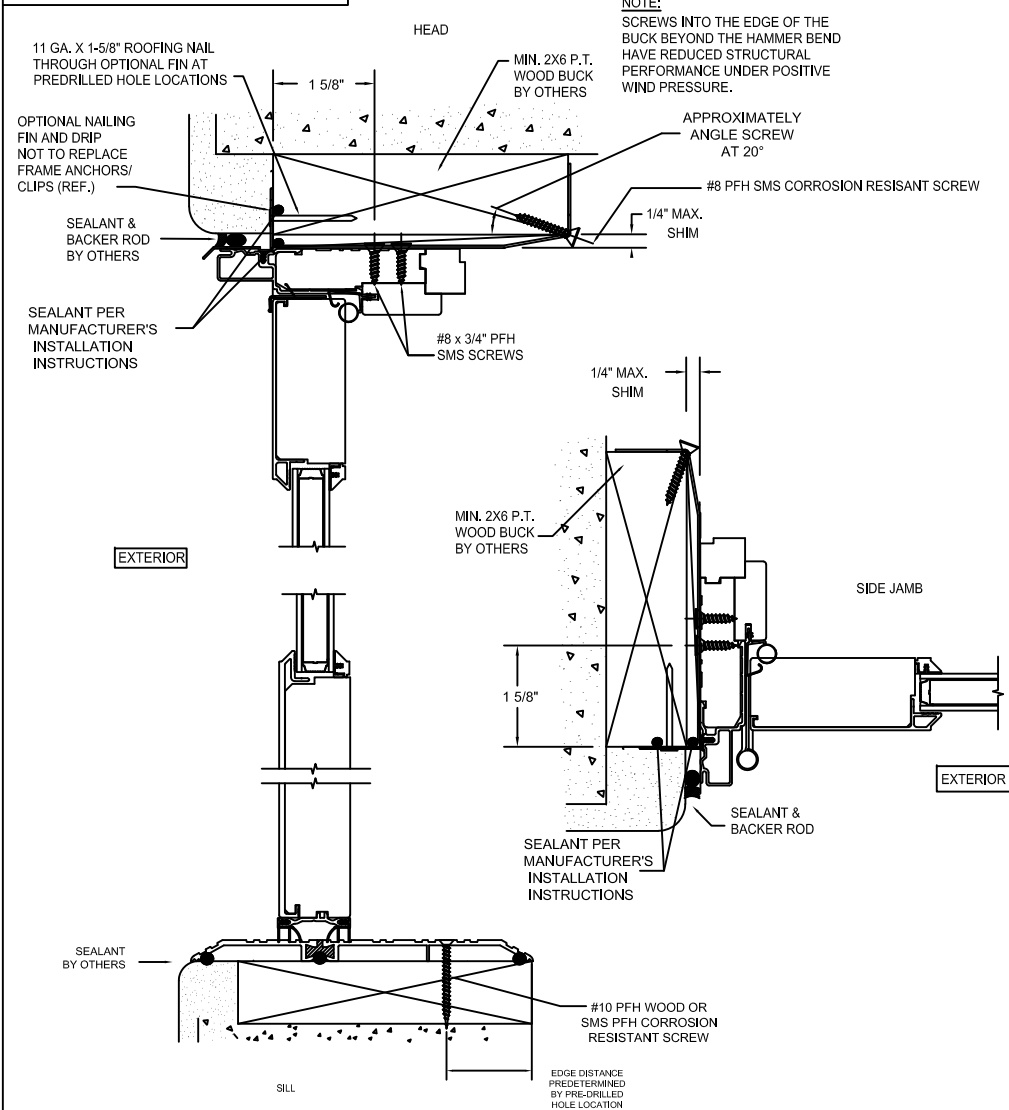

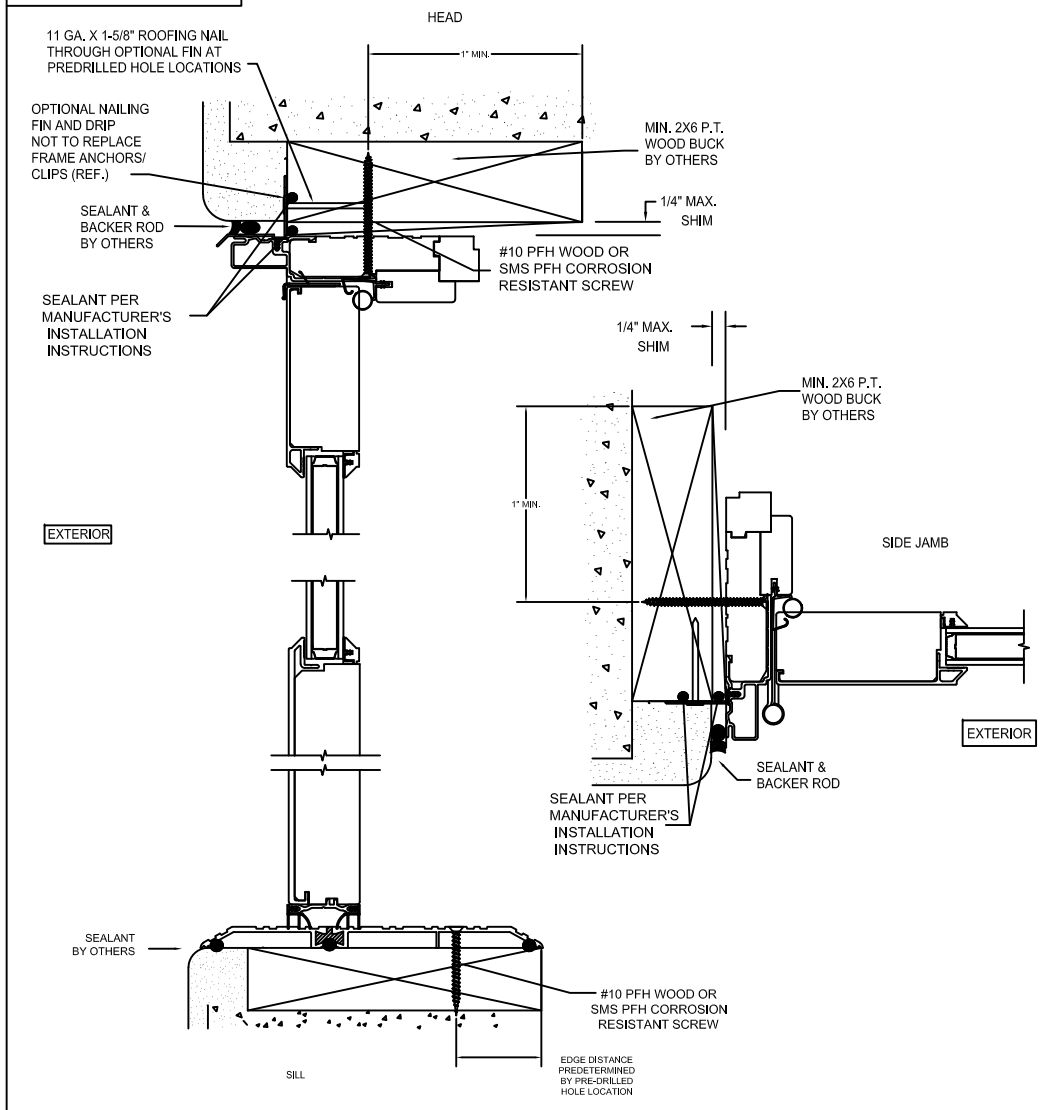
