<b>Metal Shingles and Accessories:</b>	Install the "S-Tile" Panel" and accessories in compliance with the current published installation instructions and details in Berridge Manufacturing Company's Installation Manual. Flashings, penetrations, valley construction and other details shall be constructed in compliance with Roofing Application Standard RAS 133.	
	Fasteners shall be installed in the valleys of the panel corrugations with corrosion resistant #14-10 self-drilling HWH screws with self-sealing washers of sufficient length to penetrate through the sheathing a minimum of $\frac{3}{16}$ ". Fastening shall be in accordance with <b>Table B</b> herein.	
	Sidelaps shall be attached with $\frac{1}{4}$ " – 14 x 7/8" HWH screws with self-sealing washers 14" o.c. (at every tile step).

2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners).
3. Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133
4. All panels shall be permanently labeled with the manufacturer's name and/or logo, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.






## DETAIL A
