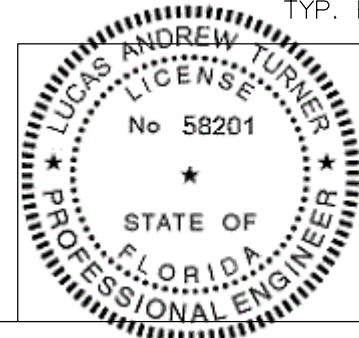


1 VERTICAL CROSS SECTION (2X BUCK)

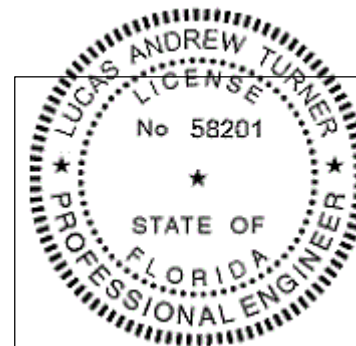

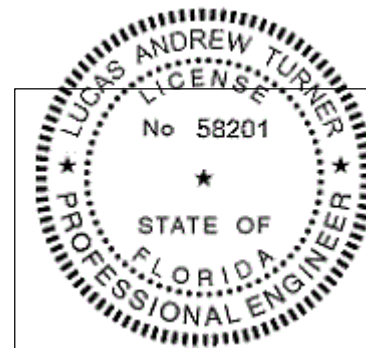


3 HORIZONTAL CROSS SECTION (1X BUCK)

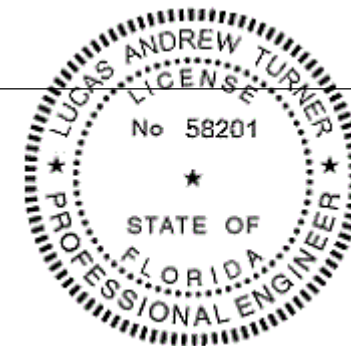

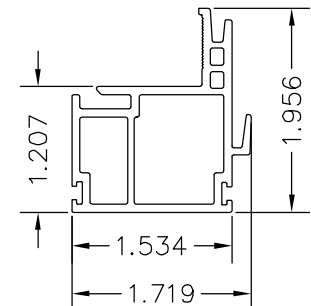

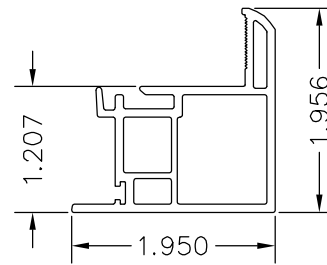
