- silicone caulk (typ.) Seal flange/frame to substrate. Sill shall be set on a continuous serpentine bead of structural grade
- Use #8 SFH or greater fastener through the head & side jambs with sufficient length to penetrate a minimum of 1 1/2" into the wood framing. For 2x wood frame substrate (min. S.G. = 0.42)
- Use (1) #8 TFH or greater fastener through each Hinge with sufficient length to penetrate a minimum of 1 1/2" into the wood framing.
