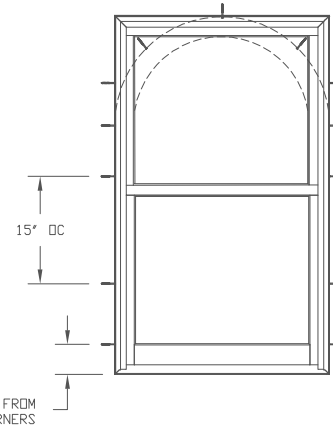
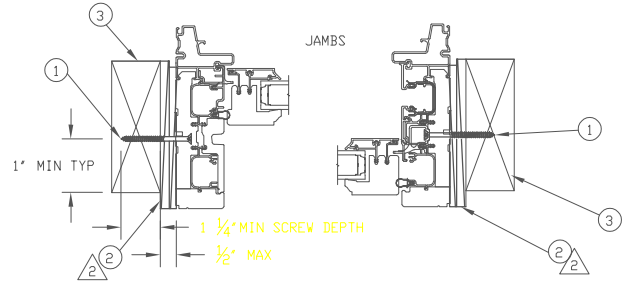
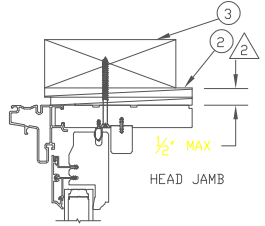


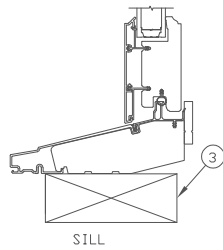
JAMB SCREW INSTALLATION

JAMB SCREW INSTALLATION METHOD:
 - UNIT MUST NOT BE IN DIRECT CONTACT WITH EITHER CONCRETE OR TREATED BUCK MATERIAL. IF SHIM SPACE IS LESS THAN 1/8" WRAPPING THE UNIT ON ALL 4 SIDES WITH WINDOW FLASHING TAPE IS REQUIRED AS A BARRIER BETWEEN THE UNIT AND CONCRETE OR TREATED LUMBER.
 - MINIMUM OF 3 SCREWS PER SIDE.
 - ADD #8 X 3" SCREWS THROUGH JAMB 6" FROM SILL AND 15" ON CENTER AND 1' DOWN FROM SPRINGLINE. ADD SCREWS THROUGH RADIUS HEAD JAMB 1' UP FROM SPRINGLINE AND AT MIDPOINT AND QUARTER POINTS ALONG RADIUS

 1. THIS PRINT IS FOR STRUCTURAL PERFORMANCE ONLY. FOR FLASHING & SEALING REQUIREMENTS, REFER TO THE INSTALLATION INSTRUCTIONS.
 SHIMS:
 - A SHIM MUST BE PLACED AT THE CHECK RAILS AND 4-6" FROM EACH CORNER.
 - ALL OTHERS MUST BE PLACED A MAX OF 15 INCHES APART.
 3. IF CHEMICALLY TREATED LUMBER IS USED FOR BUCK MATERIAL, FASTENERS INTO THE BUCK MUST BE A MINIMUM OF 0.90 OZ/FT² ZINC HOT DIPPED GALVANIZED OR STAINLESS STEEL TYPE 304 OR 316.
 4. RECTANGULAR UNITS SHOWN, SHAPED UNITS ALSO APPLY.
