Install the "Snap-Clad .032" x 18" Wide Aluminum Panel" panels including flashing **Accessories:** penetrations, valleys, end laps and accessories in compliance PAC Contractors

Association's current, published installation instructions and in compliance with the

minimum requirements detailed in Roofing Application Standard RAS 133.

Panels shall be installed along the rib with SNAP CLAD Clips secured with #14 x 6" pan head screws (2 per clip for individual clip; 8 per clip for continuous clip); the screws shall be of sufficient length to penetrate through the deck a minimum of  $\frac{1}{2}$ . The female rib of panel is snapped over the male rib of panel. Panel clips shall be spaced a maximum distance

listed below in Table A.

- **3.** Panels may be roll formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133.
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, city, state, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




- 5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
