NOTES:

1. This installation has been evaluated for use in locations adhering to the Florida Building Code and where design pressure requirements as determined by ASCE 7 Minimum Design Loads for Buildings and Other Structures do not exceed the design pressure ratings listed herein.
2. All interior and exterior perimeter surfaces of the window must be caulked.
3. Anchors shall be specified and spaced as shown. Anchor embedment into base material shall be beyond wall dressing or stucco and into wood or concrete.
4. Wood bucks (by others) must be engineered and anchored properly to transfer loads to the structure.
5. The responsibility for selection of Simonton products to meet any applicable local laws, building codes, ordinances, or other safety requirements rests solely with the architect, building owner, or contractor.
6. Shims are optional. Max. shim stack is 1/4".
7. Installation screws should be a minimum of 3/4" from the edge of the wood.
8. If 2" x 4" bucks are used, anchor screws may be inserted through the interior track. Anchor screws used in exterior balance track should be flush with the vinyl.
9. When used in areas requiring impact protection, this product DOES NOT REQUIRE the use of impact resistant shutters or other external protection.
10. Quantity of anchors attaching the jamb to the mullion will vary depending on the height of the unit. Distance between anchors must not exceed 12 inches on center.
11. Flashing should be applied using the ASTM E 2112 methodology appropriate for the opening into which the window is being installed.
12. Glazing shall comply with ASTM E 1300-04.
