Limitations of Use: This product:

- May be used with door heights up to 95_1/2", with 45 5/8" max. panel widths and 41 1/2" x 85 7/8" max. glass DLO sizes
- Achieves the design pressures shown in CWS-496E
- Is non-impact resistant and requires the use of shutters in windborne debris regions
- May be used in the High Velocity Hurricane Zone
- Requires 3/16 Tempered Air 3/16 Tempered glass minimum
- Requires Quanex or Veka white rigid PVC framing per current Miami-Dade NOA. I have evaluated these framing materials and find that they comply with the requirements of the 8th Ed. (2023) Florida Building Code for use in this product.
