### Limitations:

1. This product has been evaluated and is in compliance with the 8th Edition (2023) Florida Building Code (FBC) structural requirements excluding the "High Velocity Hurricane Zone" (HVHZ).
2. When used in areas requiring wind borne debris protection for installations above 30 feet above grade, this product complies with FBC Section 1609.1.2 as a small missile impact resistant product and does not require an impact resistant covering. This product meets missile level "A" as defined in ASTM E 1996. For installations 30 feet or less above grade, this product must be protected with an impact resistant covering that complies with FBC Section 1609.1.2.2.
3. The system detailed herein is generic and does not provide information for a specific site. A licensed engineer or registered architect shall prepare site specific documents (including framing support and connections) to be used in conjunction with this document.
4. Permit holder shall verify the adequacy of the existing structure to withstand new superimposed loads.
