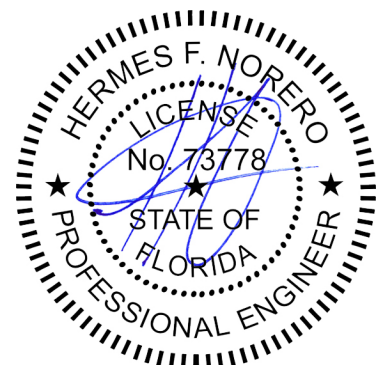

**Installation:** 1. Approved anchor types and substrates are as follows:

**Through Frame or Anchor Strap Installation:**

- A. For two by (2X) wood frame substrate, use **#14 Wood Screw** type wood frame anchors of sufficient length to achieve minimum embedment of 1-1/2" into wood framing.
- B. For concrete or masonry substrate where one by (1X), non-structural, wood bucking is employed, use **1/4" diameter ITW Tapcon** type concrete screw anchors of sufficient length to achieve minimum embedment of 1.25" into concrete or masonry.
- C. For concrete or masonry substrate where wood bucking is NOT employed, use **1/4" diameter ITW Tapcon** type concrete screw anchors of sufficient length to achieve minimum embedment of 1.25" into concrete or masonry.

**Nail Fin Installation:**

- A. For two by (2X) wood frame substrate, use **#14 Wood Screw** type wood frame anchors of sufficient length to achieve minimum embedment of 1-1/2" into wood framing.

Refer to Installation Instructions (**JW026**) for anchor spacing and more details of the installation requirements.

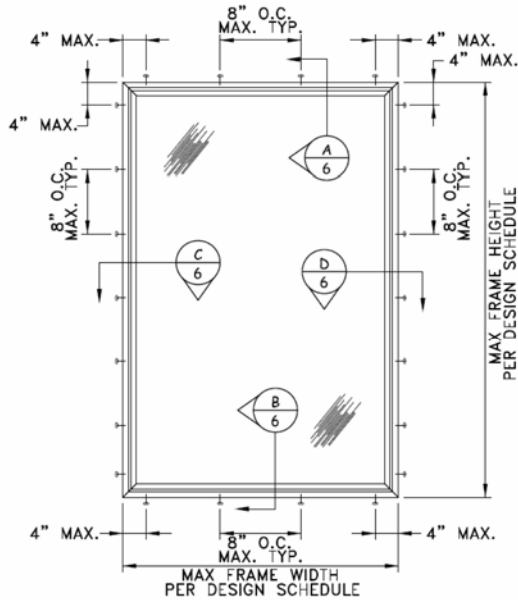

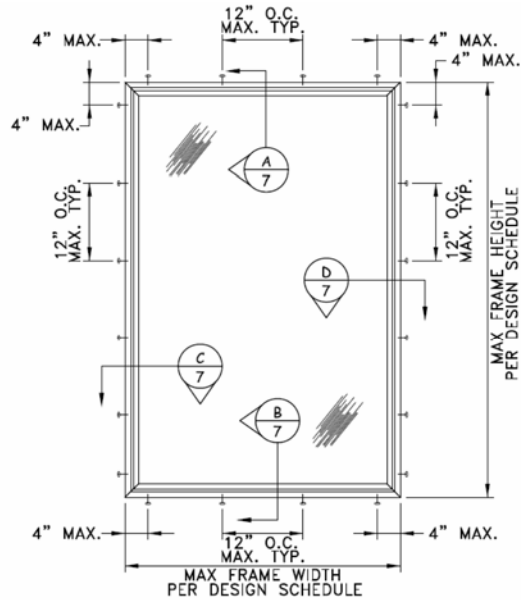

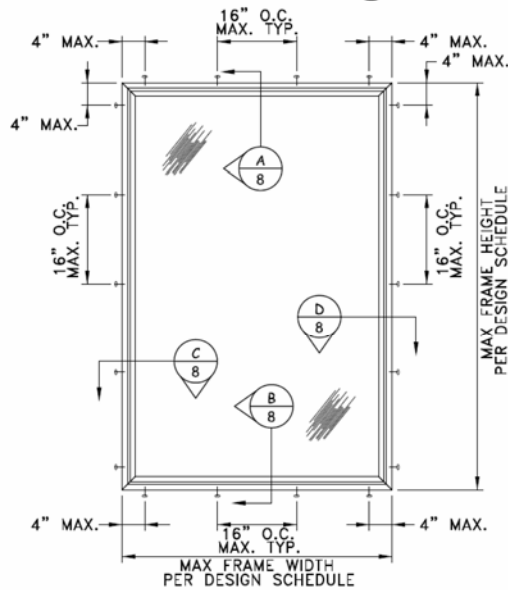
