- Requires 1" overall I.G. consisting of 3/16" tempered outboard, and inboard laminated glass made up of 3/16" annealed 0.090" Kuraray SentryGlas Interlayer 3/16" annealed
- Is Large Missile Impact Resistant and does not require the use of shutters
- May be used in the High Velocity Hurricane Zone
- Requires Deceuninck PVC extrusions per Miami-Dade N.O.A. #13-1203.02[†]
- Requires Kuraray SentryGlas Interlayer per Miami-Dade N.O.A. #14-0916.11[†]
