Limitations:

- 1. This product has been evaluated and is in compliance with the 8th Edition (2023) Florida Building Code (FBC) structural requirements including the "High Velocity Hurricane Zone" (HVHZ).
- 2. Product anchors shall be as listed and spaced as shown on details. Anchor embedment to base material shall be beyond wall dressing or stucco.
- 3. When used in the "HVHZ" this product complies with Section 1626 of the FBC and does not require an impact resistant covering.
- 4. For 2x stud framing construction, anchoring of these units shall be the same as that shown for 2x buck masonry construction.
- 5. Site conditions that deviate from the details of drawing FL-16216.3 require further engineering analysis by a licensed engineer or registered architect.
- 6. This product meets the water infiltration requirements for the "HVHZ".
- 7. See drawing FL-16216.3 for size and design pressure limitations.
