- 3. When used in areas requiring wind borne debris protection this product is required to be protected with an impact resistant covering that complies with FBC Sections 1609.1.2 & R301.2.1.2.
- 4. Site conditions that deviate from the details of drawing FL-17460.2 require further engineering analysis by a licensed engineer or registered architect.
- 5. See drawing FL-17460.2 for size and design pressure limitations.
