Limitations:

- 1. This product has been evaluated and is in compliance with the 8th Edition (2023) Florida Building Code (FBC) structural requirements excluding the "High Velocity Hurricane Zone" (HVHZ).
- 2. Product anchors shall be as listed and spaced as shown on details. Anchor embedment to base material shall be beyond wall dressing or stucco.
- When used in areas requiring wind borne debris protection this product complies with FBC Sections 1609.1.2 & R301.2.1.2 and does not require an impact resistant covering. This product meets missile level "D" and includes Wind Zone 4 as defined in ASTM E1996 and FBC Sections 1609.1.2.2 & R301.2.1.2.1.
- 4. For 2x stud framing construction, anchoring of these units shall be the same as that shown for 2x buck masonry construction.
- 5. Site conditions that deviate from the details of drawing FL-20468.4 require further engineering analysis by a licensed engineer or registered architect.
- 6. Fiber-Classic & Smooth-Star Door panels require the use of "J" part numbers and must be stained or painted within six months of installation
- 7. See drawing FL-20468.4 for size and design pressure limitations.
