**Scope:** Product Evaluation report issued by R W Building Consultants, Inc. & Lyndon F. Schmidt, P.E. (System ID # 1998) for Premier Products, Inc., based on Rule Chapter No. 61G20-3, Method 1D of the State of Florida Product Approval, Department of Business & Professional Regulation.

RW Building Consultants and Lyndon F. Schmidt, P.E. do not have nor will acquire financial interest in the company manufacturing or distributing the product or in any other entity involved in the approval process of the product named herein.

**Limitations:**

1. This product has been evaluated and is in compliance with the 7th Edition (2020) Florida Building Code (FBC) structural requirements including the "High Velocity Hurricane Zone" (HVHZ).
2. Product anchors shall be as listed and spaced as shown on details. Anchor embedment to base material shall be beyond wall dressing or stucco.
3. When used in the "HVHZ" this product complies with Section 1626 of the Florida Building Code and does not require an impact resistant covering.
4. Site conditions that deviate from the details of drawing FL-41788.17 require further engineering analysis by a licensed engineer or registered architect.
5. Outswing configurations using high water dam threshold item #78 meet water infiltration requirements for "HVHZ".
6. Outswing configurations using sill item #40, #41 and #42 do not meet the water infiltration requirements for the "HVHZ" and shall be installed only in non-habitable areas or at habitable locations protected by an overhang or canopy such that the angle between the edge of canopy or overhang to sill is less than 45 degrees.
7. All steel shall be protected as specified in Section 2222.6 of the FBC.
8. See drawing FL-41788.17 for size and design pressure limitations.
