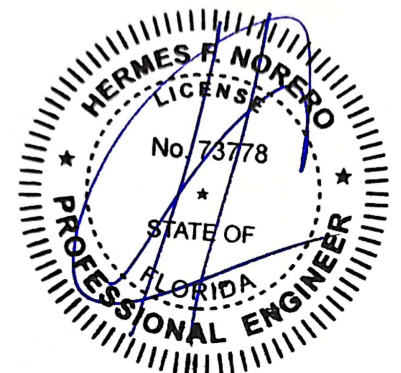

4. Site conditions that deviate from the details of installation instructions **DRU004** require further engineering analysis by a licensed engineer or registered architect.
